COMMENTS FROM VISITORS

Mr. Michael Farmer to Address the Board: Mr. Michael Farmer reported two of his children were on the bus when the bus accident occurred. He hoped the District would review its policy procedure on the matter as he felt parents should have been called immediately no matter how minor the incident. Discussion followed. He quoted from the District handbook and had several concerns and questions. President Rodney Gvillo reported notes were taken and he thanked him for his time.

Mr. Kevin Meyer – Discuss Wolf Ridge Addition: Mr. Kevin Meyer of FGM Architects handed the Board members two building concepts for the addition of another wing to the existing Wolf Ridge School. The plans would add 5 classrooms, bathrooms, a science lab, locker rooms, and a gymnasium to accommodate the 6th, 7th, and 8th grade students. The campus would then house Kindergarten through 8th grade students. Discussion followed. The Board liked option plan “A” best. Mr. Meyer will be present at the next Building Committee meeting.

The plan must be brought before the Board for approval and then submitted to the State. Discussion followed. INFORMATION ITEMS

Mrs. Marg Rogers: Mrs. Rogers reported on the enrollment figures for the Estimated Average Daily Attendance Report, the bus accident, curriculum beyond the three “R’s”, the “BIMP” funding update, and the monthly cafeteria report. Discussion followed.

Mr. Brad Skertich: Mr. Skertich thanked all who helped with the Secret Santa Project. He thanked Parents for Kids for giving the school a check for \$588.75 in sales from Santa’s Workshop. He gave an overview of comparison statistics of ISAT results from surrounding schools for 2005, 2006, and 2007. Our District faired very well. Discussion followed.

Mr. Doug Daugherty: Mr. Daugherty invited the Board to attend “Senior Night” which is the January 31st girls’ basketball home game against Greenfield High School.

He reported 104 students helped raise \$9,892.00 plus \$6,000 - \$7,500.00 in food, toys, household supplies, and clothing for the Secret Santa Project that in turn helped 21 families with 52 children within the District. The project along with other groups in the surrounding areas helped an additional 50-75 children.

Mr. Daugherty gave an overview of comparison statistic results from other Macoupin County schools on the percentage of students meeting or exceeding standards on the PSAE Test from 2005, 2006, and 2007. Discussion followed.

Miss Heather Gvillo: Miss Gvillo thanked the Board for allowing her and four other high school seniors to take Lewis and Clark Community College classes this semester. Having already taken several college dual credit course classes during high school, Heather will start college with 14 accumulated credits under her belt. She thanked the Board for the advancement.

Miss Sydney Strohmeier: Miss Strohmeier questioned whether any more thought was given to buying additional Chemistry books. Mr. Daugherty looked into the issue and will purchase a whole new Chemistry series next fall.

Mr. Greg Lievers: Mr. Lievers reported having to repair aging steam lines from the Meissner boiler. He also reported the sump pump in the high school boiler room was replaced.

Mrs. Shelle Wuellner thanked the Board for allowing her to be a part of the Bunker Hill School District. She reported the students are wonderful and she is very excited to work here and cheer the students to victory. She handed the Board a sample survey given to her cooks asking for ideas to better serve the food program. Shelle reported on the recent food service inspections. She also included a list of salads/salad dressings/fruit and vegetables available through the cafeteria. Shelle told the Board she was extremely unhappy with the present bread company. The District bids bread and milk with Mt. Olive, Gillespie, and Staunton to receive a better price. Bunker Hill is in a different region than the other three schools. She would like to buy from a different company next year. Discussion followed. She mentioned there is adequate space by the high school Ag Shop to house a bigger walk in cooler/freezer to meet the needs of the District. Discussion followed.
